

## **The HKIE COVID-19 Vaccination Campaign (“Campaign”)**

To support and encourage COVID-19 vaccination among the HKIE members, the Hong Kong Institution of Engineers (HKIE) organises a campaign offering members of the HKIE, who have received two doses of the COVID-19 vaccination a one-off full membership fee waiver for financial year 2022/2023 (“the Prize”). One hundred membership fee waivers will be given out by a Luck Draw.

Potential participants shall have sole responsibility for receiving COVID-19 vaccination. They are advised to consult their doctors and seek medical advice before vaccination.

### **Rules and Conditions**

#### **Eligibility**

- All classes of HKIE members from any disciplines.
- Participants shall have attained the age of 18 on or before 31 August 2021.
- Participants shall have received two doses of the COVID-19 vaccines in Hong Kong under the COVID-19 Vaccination Programme implemented by the Hong Kong SAR Government on or before 31 August 2021. Both doses of the respective vaccines must be received in Hong Kong.

*None of the parties (including HKIE staff and members) who are involved in the design, operation and execution of the Lucky Draw campaign shall be eligible to participate in the Lucky Draw.*

#### **Registration**

- All registration must reach the HKIE Secretariat via [online registration form](#) no later than 5:30pm (Hong Kong time) on 15 September 2021 (Wednesday).
- Late registration would not be considered.
- If the number of eligible participants of the Campaign is more than 100, the winners would be determined by drawing lots (“Lucky Draw”).
- Each eligible participant can each get one (1) Lucky Draw chance. Any duplicated registration will be disregarded and will not be entitled to more entries to the Lucky Draw.

Lucky Draw winners will be drawn on Monday, 20 September 2021 at the HKIE among the registered participants randomly and a witness would be invited to observe

the Lucky Draw process.

The result will be published in The Standard and Sing Tao Daily on Tuesday, 28 September 2021. Winners would also be notified via email given at registration.

### **Prize and Redemption**

- Winners are required to provide their copy and/or electronic record of their COVID-19 vaccinations issued by the Department of Health of the Hong Kong Government, as well as providing written consent for HKIE to verify their vaccination record with Government, if deemed necessary. Winners who fail to do so would be disqualified.
- The prize is one-off full membership fee waiver for financial year 2022/2023.
- The amount of the Prize is subject on the grade of the members entitled for the free membership of financial year 2022/2023.
- All the prizes for the Campaign are not redeemable for cash and are not transferrable.

### **Personal Information Collection Statement**

- In this registration, participants will be requested to provide some personal data. The provision of personal data is voluntary and it will assist in processing the registration to the Luck Draw. However, if the necessary personal data is not provided, it may not be possible to process or consider the registration. Please read the following statements about the use of participant's personal data and rights in respect of them.
- The personal data provided by means of this registration will be used for the purposes relating to the Lucky Draw only, and may be transferred to third parties for auditing purpose.
- In accordance with Sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance, participants have the right to request access to and request the correction of the data provided by them.
